Energy-Saving Measure	Basic Specifications	Incentive
Floor Insulation*	Equal to or greater than R-30 or to fill cavity <sup>†</sup> , prior condition must not exceed R-11	\$0.45 per sq. ft.
Wall Insulation*	Equal to or greater than R-11, prior to condition must not exceed R-4	\$0.30 per sq. ft.
Ceiling or Attic Insulation*	Equal to or greater than R-38, prior condition must not exceed R-18	\$0.25 per sq. ft.
High-Efficiency Natural Gas Furnace*	90% AFUE, or greater	\$150
PTCS Duct Sealing*	Ducts must be sealed to PTCS standards	\$150
High-Efficiency Natural Gas Furnace + PTCS Duct Sealing*	90% AFUE, or greater Ducts must be sealed to PTCS standards	\$300
High-Efficiency Natural Gas Hearth	80% AFUE, or greater	\$70
Conventional Natural Gas Water Heater**	.62 EF, or greater	\$25
Tankless Natural Gas Water Heater**	.81 EF, or greater	\$200
ENERGY STAR® Clothes Washer**	2.0 MEF, or greater	\$75

# Program Rules and Requirements

## How to Qualify for Cascade Natural Gas Existing Homes Incentives

### Step One

Establish your eligibility. Call 1-866-626-4479 or visit [www.cngc.com/conservation](http://www.cngc.com/conservation) for program requirements.

### Step Two

Install energy-efficient home improvements. Contact a participating Trade Ally contractor to install eligible measures.

### Step Three

Acquire appropriate rebate form online at [www.cngc.com/conservation](http://www.cngc.com/conservation), or call 1-866-626-4479.

### Step Four

Sign and submit forms. Submit a copy of your contractor's invoice, with appropriate rebate form, to:

Upon receipt of completed application, please allow six to eight weeks for processing and payment.

## Who is eligible to participate?

- Washington residential customers of Cascade Natural Gas on rate schedule 503 (see your gas bill).
- Primary home heat-source fuel must be provided by Cascade Natural Gas for all heating incentives.
- Water-heating fuel must be provided by Cascade Natural Gas for all water-heating incentives.
- Energy-saving measures must meet program requirements. Details at [www.cngc.com/conservation](http://www.cngc.com/conservation).
- All equipment and service measures must be installed by a Washington-licensed contractor.
- Attic/ceiling and floor insulation eligible for self-installation. Call us at 1-866-626-4479 before beginning work to receive pre-approval.
- Building code-required materials are not eligible for incentives.
- Incentives are effective until December 31, 2009, and may be subject to change.
