Decisions Made: None Noted Discussion:

- Brian provided an update on the progress of C/I customers.
- Bellingham SD and Megalodon LLC were a couple of large therm saving projects.
- Marketing activities include Clean Buildings webinar, LinkedIn ads, geo-fenced ads, contractor breakfasts, and billboard campaigns.
- Boilers and insulation are the two most prolific measures.
- Targeting large therm savings from greenhouse heat curtain projects and school retrofits.
- Sluggish economy in 2025 is causing some challenges in completing EE projects.
  - Economic slowdown, inflation, tariffs
  - Electrification trend (e.g., Skagit Valley College)
  - Politically motivated project cancellations (e.g., Whidbey Naval Air Station)
- Quinn asked if TRC is seeing more larger customers shift over to electrification projects; if that trend line is anticipated to continue; and, what the agricultural heat curtain is?
  - Brian stated that it looks that way that the electrification shift will continue, Zone 3 and Western
     WA are where we are seeing the biggest impact currently.
  - Brian stated it is hard to say if the trend line will continue. Caleb also responded by informing this was something that was considered in our 2025 CPA.
  - Brian stated that heat curtains have been used in both cut flower operations and marijuana
    growing facilities. They are essentially able to use less heat because they are able to trap heat
    from lighting and natural gas heating, these curtains are able to retain more of the heat. Will
    have Bob Cuti, our technical manager, follow up with Quinn to share more details.

Residential Program Highlights and Activity through Q4 2024 - led by Caleb Reimer - 00:28

Action Items: None
Decisions Made: None
Noted Discussion:

- 93% of annual therm savings goal achieved by mid-year.
- 119% of budget spent YTD, due to increased therm savings and incentives compared to plan. Possibility of exceeding 120% of the planned annual budget by year end.
- 35% increase in processed measures first half of 2025 compared to 2024.
- On track to exceed our portfolio biennial goal of 1.78 million terms, 91% currently achieved through 75% of the period.

Home Energy Reports Round 1 M&V - led by Sedge Lucas (ADM) - 00:32

Action Items: None
Decisions Made: None
Noted Discussion:

- Evaluated 2023–2024 Home Energy Report (HER) pilot implemented by Brillion.
- Approximately 10,000 treatment and 5,000 control customers were included in the Round 1 pilot.
- Used difference-in-difference regression models for statistical analysis, among other methods.
- The results were 6 of 128 models showed statistically significant savings at the .1 confidence level
- Some limitations were small sample size, lack of peer comparison, and broad customer targeting.
- Round 1 provided excellent learnings for the program. Recommendations for Round 2:
  - Increase sample size (30,000 treatment, 10,000 control)
  - Consider including some form of peer comparisons

## Home Energy Reports Round 2 Proposal – led by Aaron Savatti & Alex Corneglio (Brillion) - 01:00

Action Items: None
Decisions Made: None
Noted Discussion:

- The ending treatment group expanding from 9,000 to 30,000 customers.
- The ending control group expanding from 4,000 to 10,000.
- Digital-only reports to reduce costs and improve tracking.
- Timeline: Launch in September 2025, results around December 2026.
- Focus on improved statistical power and collaboration with ADM.
- Questions raised by Quinn and Shaylee about language accessibility and the inclusion of low-income customers.
  - Caleb and team acknowledged the importance and committed to exploring options for future phases.

## <u>Low-Income Program Updates</u> – *led by Noemi Ortiz* – 01:25

Action Items: None Decisions Made: None Noted Discussion:

- 39 projects completed, 156 measures installed.
- \$1.2M spent (of \$1.7M annual budget).
- Average cost per project increased to \$26,000 due to contractor costs and reduced federal funding.
- Pilot program launched with third-party contractors to address CARES backlog.
- Goal: 40 pilot projects by February 2026.
- Address CARES backlog and test alternative delivery models.

## Regulatory Timeline, EM&V Updates – led by Jodie Albert – 01:40
