

# Notice to the Public | Oregon Service Area

On July 31, 2024, Cascade Natural Gas Corporation filed for approval from the Oregon Public Utility Commission (OPUC) to recover actual 2022 and 2023 costs to comply with the requirements established by the Oregon Department of Environmental Quality in Oregon Administrative Rule (OAR) 340-271, Oregon Climate Protection Program (CPP). This filing has a requested approval date of November 1, 2024.

The OPUC will review this filing and has the authority to set final rates that may vary from Cascade's requests, either higher or lower, depending on the results of its investigation. If the OPUC approves Cascade's filing, it will result in an annual increase of \$6,003,320 or 5.42% in overall collections. A typical residential customer using 57 therms per month with an average monthly bill of \$72.07 can expect to see a monthly increase of \$2.44 or 3.39% per month.

The proposed rate changes for residential, commercial, and industrial customers are:
