

# Notice to Public | Oregon Service Area

On November 19, 2024, Cascade Natural Gas Corporation (Cascade) filed to increase its Schedule 31, Public Purpose Charge from 3.455 percent to 6.456 percent, effective January 1, 2025. The collections from this charge are used to fund Energy Trust of Oregon delivered conservation programs and Cascade-administered income-qualified programs for weatherization and bill payment assistance.

The OPUC will review this filing and has the authority to set final rates that may vary from Cascade's request, either higher or lower, depending on the results of its investigation. If the OPUC approves Cascade's filing, it will result in an annual increase of \$5,867,036 in overall collections. The total increase for a typical residential customer using 56 therms per month with an average proposed monthly bill of \$64.73 can expect to see a monthly increase of \$1.82 or 2.80 percent per month. The proposed rate changes for residential, commercial, and industrial customers are provided on the back side of this insert.
