Cascade Natural Gas Corporation ("Cascade" or "Company") submits to the Washington Utilities and Transportation Commission ("Commission") the following revision to its Tariff WN U-3, stated to become effective with service on and after <u>September 1, 2025</u>:

Sixtieth Revision of Sheet No. 500-A

The purpose of this filing is to revise Schedule 500, Municipal Taxes, so that the City of Lynden tax charged and the applicable limitations are consistent with the terms and conditions adopted by the City of Lynden on July 21, 2025, in Ordinance No. 25-1714, which is included with this filing as Attachment A.

In accordance with WAC 480-80-122, Cascade is requesting a waiver from WAC 480-80-121(1), which requires that "the commission must receive tariff changes not less than thirty days in advance of the requested effective date" in order that the changes may become effective September 1, 2025, which is the effective date of the tax change as established Attachment A. Included with this filing is a Less Than Statutory Notice (LSN) form.
