Cascade Natural Gas Corporation ("Cascade") herewith submits to the Washington Utilities and Transportation Commission ("Commission") the following revisions to its Tariff WN U-3, stated to become effective with service on and after July 25, 2024:

Thirtieth Revision of Sheet No. 2-A Second Revision of Sheet No. 556 Second Revision of Sheet No. 700.1

Cascade makes the following changes in this housekeeping filing:

- <u>Sheet No. 2-A.</u> The Table of Contents is revised to add reference to Schedule 520, Provisional Plant Rate Adjustment, which was approved in Docket UG-250307. Cascade was not able to update the Table of Contents in Docket UG-250307 because the sheet was suspended in Cascade's prior housekeeping filing, docketed as UG-250187.
- <u>Sheet 556.</u> The COVID-19 Cost Recovery Adjustment was approved in Cascade's most recent multi-year rate case (UG-240008). While the adjustment was initially designed to collect COVID-19 costs over two years, the final settlement agreement, approved as Appendix A to Commission Order No. 05, issued in UG-240008, agreed this schedule would have a three-year term. Schedule 556, as submitted in Cascade's final compliance filing, inadvertently retained the initially proposed term ending February 28, 2027. Cascade corrects the term in this filing so that it ends February 28, 2028, clarifying that this schedule has a three-year term rather than a two-year term

• <u>Sheet No. 700.1</u>. The definition of low-income residential customer includes the extra word, "customers," which is removed with this filing.

The costs collected in this schedule are deferred in accordance with Orders 01, 02, and 03 issued in UG-2000479.

APPLICABILITY

CLIMATE COMMITMENT ACT (CCA) RATE ADJUSTMENT SCHEDULE NO. 700

AVAILABILITY

This schedule is applicable to Schedule 503, 504, 505, 511, 570, and 663 customers with the exception of those customers identified in the Exemptions section below.

PURPOSE

The purpose of this schedule is to collect costs incurred and credit revenues received in compliance with the Climate Commitment Act (CCA) as codified in Revised Code of Washington (RCW) 70A.65 and Chapter 173-446 of the Washington Administrative Code (WAC).

LOW-INCOME RESIDENTIAL CUSTOMER

For the purpose of this adjustment schedule, a low-income residential customer is a customer who receives gas service on Schedule 503 and simultaneously is actively enrolled in the Cascade Arrearage Relief and Energy Savings (CARES) program as defined in Rule 20 and offered per Schedule 302, regardless of whether or not the CARES discount has been temporarily suspended for the application of a Low-Income Home Energy Assistance Program (LIHEAP) grant.
