A reconnection charge may be required for reestablishment of service at the same address for the same customer taking service, if service was disconnected at the customer's request or if it was disconnected involuntarily for reasons other than for Company initiated safety reasons or maintenance.

II. <u>Disconnect Visit Charge (Rule 5)</u>:

A field visit charge may be assessed whenever Cascade visits a customer's address for the purpose of disconnecting service or reconnecting service and, due to the customer's action, is unable to complete the disconnection or reconnection.

III. Late Payment Charge (Rule 6):

1.0%

Unless otherwise specified in the customer's contract, a late payment charge at the rate of 1.0% per bill cycle may be applied to all unpaid balances in accordance with Rule 6.

IV. Returned Check Charge (Rule 6):

VI. <u>Tampered Meter Charge (Rule 6)</u>:

Actual costs

A Tampered Meter Charge will be applied when a customer tampers with any part of the service line or meter or any other Company apparatus. The charge will be the actual costs of damages, repairs or an additional or unusual costs or services directly related to the interference, plus any unbilled gas usage as determined by the Company and the appropriate reconnection charge.
