WSEC Energy Credits Explained

- Under the 2018 Residential State Energy Code, additional energy efficiency requirements must be met
- To meet the minimum credit requirements, both a 'Carbon Emission Equalization' option based upon the energy source for the primary heating source, and sufficient 'Energy Credits' must be selected
- For detailed requirements and a complete description of each energy credit, please refer to WSEC Section R406, notably Table R406.2 and Table R406.3

Small Dwelling Unit	<1500sf and <300sf of fenestration	3.0 credits req'd
Medium Dwelling Unit	1500-5000sf of conditioned floor area	6.0 credits req'd
Large Dwelling Unit	>5000sf of conditioned floor area	7.0 credits req'd

While there are countless ways to achieve code compliance, the following packages demonstrate common pathways towards compliance. For most homes, 6.0 credits are required; therefore, the following panels present options for achieving 6.0 credits.
